- Lack of embracing change (gathering member emails for better communication, Social Media presence (more recognition of high scores, tournament results), phone-in conference calls, provide way for league secretaries to more easily submit scores to NDBC database, Social Divisions in tournaments, etc.)

- Make NDBC meeting times convenient/accessible so more members can attend & participate

Diversity of opinions are not welcomed

- BAC members volunteer their time without asking for anything in return. NDBC dismissive of BAC thoughts/ideas/opinions

- Changes need to be made, willing to try new things. If no change, game will be left behind

- Important to strike balance between holding our ground on these topics while also not coming across as adversarial. Groups need to work together.
