I. Conference Call Reviews- Jack attended both calls. 1st call- Discussion of Greenmount Bowl (installed synthetic lanes, plates are 3/4" lower than lane (max is 1/2"), failed inspection twice. Also discussed National Tournament: 3 proposals (VA, Frank Wilson/Hagerstown, Stan- run state tournaments & winners to Nationals). 2nd call- VA will hold Nationals over 3 weekends in May. Issues working with Proprietors' Association. Stan wants Proprietors more involved in recruiting sanctioned bowlers & participate in NBDC.

Brian expressed frustration to NDBC in lack of communication of calls. NDBC referred to notes from last annual meeting minutes which supposedly listed dates/time of calls. NDBC raffle tickets sent with no explanation. Stan now asking for tickets back with money collected (none sold). Brian asking for return envelope/postage. BAC can reimburse cost. NDBC threatened in email to withhold rebate funds due to lack of sales.
