4.By-laws (Brian)

1. Article IV/Officers: Discussion on bonding of BAC Treasurer. Per NDBC, only league secretary/treasurers are bonded for those leagues only. Language will be changed under Section 1d. to "Each August a majority vote of the board shall determine whether and for what amount the Treasurer shall be bonded for the year beginning September 1st and ending August 31st." Section 9 changed to "Any member of the Board of Directors who fails to attend three meetings in a row or five of the six most recent meetings will be subject to removal per a majority vote of all other board members in good standing."
2. Article V/Meetings: no changes.
5.New business
1.Summer Series Discussion- Brian sent 9 no-tap summer tournament proposal to board members. Set a handful of dates at different centers/days of week over the summer, flexible start times, bowl 3 games $100 \%$ handicap off 140, unsanctioned to try and attract new bowlers or those who haven't bowled in a league/tournament recently. Reduced entry fees based on number of new bowlers recruited. $\$ 10$ per entry to prize fund, pay approximately 1 -in- 6 entries. New bowlers pay $\$ 15, \$ 5$ goes towards gift card raffle. One in 2 new bowlers get $\$ 10$ bowling gift card. Discussion over how frequently to hold tournaments (every 3-4 weeks?), day of week (known summer leagues on Mon, Wed, Thu...Tue and Fri?), which centers to hold tournaments (possibly an unsanctioned center to attract new bowlers?). Brian will reach out to proprietors to gauge interest.
