# A. Holiday Lanes - Lane Inspection (Brian)

Brian argued precedent had been set by allowing 26 of 32 lanes to be sanctioned during past four years and cited example of Lucky Strike not sanctioning two of its lanes. Still unresolved as of this meeting.

#### 4. New Business

# a. Social Events (Brian)

- NDBC has approved a trial period for the BAC to run "social events" in conjunction with our remaining tournament series events (Lucky Strike January, Johnson's January, Holiday March). These social events are for those *not sanctioned by the NDBC after January 1, 2015*. The goal of these events is to introduce new people to the competitive side of the sport and nudge them into joining leagues and becoming full BAC members.
- ii. Proposed Cost to Bowler: \$15 entry (\$12.50 lineage, \$2.50 remaining)
- iii. Proposed Prizes: \$5 off next entry coupons to at least 20 participants in each of the first two events (will mail coupons to winners)
- iv. Discuss prizes for last event after assessing success of program
- v. We must collect contact information for these players
- vi. How do we promote the event in order to get a good turnout? Target current non-sanctioned bowlers at member centers and Woodlawn. Through a bring-a-friend campaign. Get in touch with ten-pin & candlepin bowlers to distribute information. Have proprietors introduce/suggest event to open-players. Clubs/organization for events.
